



## Carnegie, Borough of, PA to utilize CodeRED Emergency Notification system

**Carnegie, PA – December 5, 2017** – The Borough of Carnegie has contracted with OnSolve to license its CodeRED high-speed notification solution. The CodeRED system provides the Borough of Carnegie and Pennsbury Village officials the ability to quickly deliver messages to targeted areas or the entire municipality.

Steve Beuter, Carnegie Borough Manager, cautioned that such systems are only as good as the telephone number database supporting them. One of the reasons the CodeRED system was selected is it gives individuals and businesses the ability to add their own phone numbers directly into the system's database, which is an extremely important feature.

“No one should automatically assume his or her phone number is included,” Beuter said urging all individuals and businesses to log onto the Carnegie Borough website, <http://www.carnegieborough.com/>, and follow the link to the "CodeRED Community Notification Enrollment" page. Those without Internet access may call the borough **(412-276-1414), Monday through Friday, (8AM-4PM)** to supply their information over the phone. Required information includes first and last name, street address (physical address, no P.O. boxes), city, state, zip code, and primary phone number, additional phone numbers can be entered as well.

All businesses should register, as well as all individuals who have unlisted phone numbers, who have changed their phone number or address within the past year, and those who use a cellular phone or VoIP phone as their primary number.

Beuter explained, "CodeRED allows geographically based delivery, which means street addresses are required to ensure emergency notification calls are received by the proper individuals in a given situation. The system works for cell phones too, but there needs to be an associated street address to provide relevant messages. CodeRED gives those who want to be included an easy and secure method for inputting information.
