**MANAGER'S REPORT**

Ms. Brady reminded everybody of the next West Busway Transit Oriental Development meeting will be held on Thursday, June 3, 2010 at 5:30 pm. This is the second meeting that will be held in the Council Chambers and ask that all who attended the first meeting to return and bring a friend or colleague to the meeting as well. Secondly, the Jefferson Street Contractor was selected tonight and was happy that the bid came in \$25,000.00 under budget for the project which is great news. This allows us some room to do signage and planting along the intersection as well. Also, the office staff is working on our CDBG year 37 application and residents along Morrow Avenue, Run Street and Lexington Court will be receiving a household survey. The Borough will be applying to the Community Development Block Grant for funds on repairing the Morrow Avenue Bridge. Responding to this survey is greatly encouraged. The more responses the Borough gets, the better chance the Borough has of getting funding for the project. Finally, next Monday the Borough will be unveiling the new hotline 1800 number which will be used whenever the Borough has something important to report to the community.

**MAYOR'S REPORT**

Mayor Kobistek read the Crime Report: arrests/citations - 42, traffic citations – 78 parking tickets – 167 and self initiated reports/complaints – 1,010. Mayor Kobistek said tomorrow he and Chief Harbin will be meeting with the owner of the Carnegie Towers and discussing current security measures. Also there were 153 DCR's issued last month. Also, for the Gas Savings Program, when anyone is at a gas station or a pizza place to please turn off their cars when running in the station to pick up items and anybody that has children with bikes have them secured at night. Also if anyone sees anybody who is not keeping up with their lawn care of vacant homes to please report this to the Borough Code Officer or if you see any suspicious activity to call 911. Mayor Kobistek also thanked Sergeant Lint and Chief Harbin for a successful Dare graduation and every sixth grader who participated did graduate and thanked Mr Veri, the school principal and Dr. Panza for a nice event.

Mayor Kobistek congratulated Julia Robb who was named National Safety Patroller of the Year who won a trip to Washington, D.C. The Boys and Girls Club is also sponsoring a fund raiser at the Library on May 22, 2010. Mayor Kobistek said that volunteers are

needed at St. John's Lutheran Church to deliver Meals on Wheels. Finally, he congratulated the Carlynton Boys Tennis program who made the playoffs and won in the first round. yesterday. Former Councilman Tim Volk's son is on the team. He also thanked everyone who serves our Country.
