PUBLIC COMMENT ON LISTED MOTIONS

Irv Ferman, representing LSPD LLC. who are property owners on Main Street down from the proposed Dunkin' Donuts. I wanted to point out a few things from the conditional use hearing last week. Under the conditional use process, it is incumbent upon the applicant to prove the established compliance with the conditional use ordinance. When it comes to the speakers and screens to not interfere with other properties, they did not do that. The engineer, in his letter dated January 22nd, told them that they needed to do that. They did not do it in the application, they did not present anything at the meeting that supports that. Aside from that and more importantly, LSPD's traffic engineer came to the meeting and said that the exit onto Williams Way is creating a hazard here and it would be quite easy for them to minimize these conflicts simply by closing off the access to Williams Way. They also showed other Dunkin' Donuts that have the horseshoe, the one in and one out, that worked better than the model being proposed. This comes down to whether they have met the code. If you feel that this needs to be approved, then I feel like you should add on the condition that you close the access to Williams Way to avoid traffic accidents. MANAGER'S REPORT – we are beginning to implement the Value Payment Systems online payment processing application so people may begin to pay online with a debit card or credit card for any borough permits and/or fees. We are hoping to have that up and running within the next few weeks. Admin is also working on a four-part blight series webinar. This will help with putting vacant properties back to use. We have just become eligible to apply for Walmart Community Grants. We can submit up to 25 applications per year. We have been working with The City Paper for them to put one of their paper boxes in Carnegie. Deneen has been working with Just Harvest, a program that will allow customers at the farmer's market to use SNAP, WIC and senior coupons. Just Harvest will have representatives present at the farmer's market. This will be a huge help as we have had numerous inquiries regarding this in the past. Finally, the business privilege tax invoices were sent out at the beginning of February with a due date of March 1. To date we have collected \$87,050.

CARNEGIE VOLUNTEER FIRE DEPT. & EMS REPORT – for the month of February 2021, there were 18 fire calls and 98 ambulance calls.

MAYOR'S REPORT- Police Dept. activity for February 2021: Criminal Arrests and Citations – 12; Traffic Citations – 13; Traffic Stops – 28; Parking Tickets – 130; Complaints and Self-Initiated Activity – 638.
