MANAGER'S REPORT

The Carnegie Borough has submitted a CDBG application for the Phase One Reconstruction of the Morrow Avenue Bridge. Ms. Brady said a household survey was mailed last month to residences on Run Street, Lexington Court and Morrow Avenue and hopes anyone who has not submitted their surveys will mail them back to the Borough Building. Also beginning August Second, the Borough is having a Walk Challenge in Partnership with Care Free Fridays. The walk is a free challenge to anybody who is interested and for more information they can contact the Municipal Building.

MAYOR'S REPORT

The Mayor said Carnegie Borough declared a Declaration of Disaster Emergency on Saturday, June 5, 2010 due to the overflow of water from Campbells Run Road. He stated that services from the Police Department, Fire Department and Volunteer Fire Department would all be made available on that day. He also thanked the Department of Public Works under the direction of Chief Harbin and Borough Manager Brady.

Ms. Demko also commended John Restich, Department of Public Works for all his efforts during the disaster with the residents.

The Mayor said they had a Relief Services Assessment meeting on June 9, 2010 with a number of social service agencies including the Salvation Army, United Way, Allegheny County, Catholic Charities and a number of local Carnegie churches and decided how they would move forward. Also in attendance were representatives from each of our local, state and federal governmental bodies. He said they established an Action Plan on how to move forward with this disaster. The Mayor stated he was confident that this needs to be moved forward quickly and indicated that this has to be set up a way where residence can be helped by the flood. He also said that on Friday evening and Saturday morning sandbags were delivered to a number of residents around the damaged area. The next round of sandbags stationed will be delivered by the Public Works department. The Mayor stated they met with the Army Corp. of Engineers Associates and issued a special thanks to Congressman Murphy who set up the meeting immediately following the flood.
