MOTION by Councilperson Veres to approve the May Bill List and Addendum. Second by Councilperson Covi. Roll Call Vote: UNANIMOUS. MOTION CARRIED

MOTION by Councilperson Veres to award the Garbage and Rubbish Contract to Allied Waste Services of Pittsburgh for a 3-year period beginning July 1<sup>st</sup>, 2011 and ending June 30<sup>th</sup>, 2014. Second by Councilperson Covi. Roll Call Vote: UNANIMOUS. MOTION CARRIED

#### Public Works (Councilwoman Demko)

#### Public Safety (Councilman Sarsfield)

MOTION by Councilperson Sarsfield to approve Resolution No. 2011-07, a Resolution of the Borough of Carnegie creating a Handicapped Parking Space near 303 5<sup>th</sup> Avenue. Second by Councilperson Covi. UNANIMOUS. MOTION CARRIED

MOTION by Councilperson Sarsfield to approve Resolution No. 2011-09, a Resolution of the Borough of Carnegie recognizing and honoring our Armed Forces and their families on this Memorial Day. Second by Councilperson D'Loss. UNANIMOUS. MOTION CARRIED

#### Community Development (Councilman D'Loss)

MOTION by Councilperson D'Loss to refer a request for the creation of an Airport Hazard Zoning Overlay District to the Borough Planning Commission for consideration and recommendation. Second by Councilperson Demko. UNANIMOUS. MOTION CARRIED

MOTION by Councilperson D'Loss to advertise the sell of Borough property located 415-417 Elk Avenue to the highest bidder with a minimum selling price of \$35,000.00. Second by Councilperson Sarsfield. UNANIMOUS. MOTION CARRIED

##### Administration & Finance – Councilman Veres

Councilman Veres reported the feasibility study to build the new elementary school in Carnegie is put on hold. The school tax will decrease by 1 mill. The school board is also reviewing the addition of new programs for the school district.

#### Code Enforcement – Councilwoman Covi

Councilwoman Covi thanked everyone who volunteered and participated in the Easter Egg Hunt.

#### Public Works – Councilwoman Demko

The Department of Public Works is working on getting the fields and parks ready for the summer season. DPW is also working on filling the potholes.

#### Public Safety – Councilman Sarsfield

Councilman Sarsfield asked all residents to keep safety in mind during the summer season. Councilman Sarsfield also applauds our military and reminded all residents to come and enjoy the Memorial Day parade.

#### Community Development – Councilman D’Loss

Councilman D’Loss reported on the success of the Civil War Reenactment and congratulated the director, Maggie, executive director of the Library/Music Hall, for a successful event.

#### Carnegie Volunteer Fire Department Report – Chief Kandrac

Chief Kandrac reported the month of April the Fire Department responded to 28 fire calls and 177 EMS calls. Chief Kandrac thanked Chief Harbin for a very successful 5K Run. He also thanked Mayor Kobistek for recognizing the members of the Fire Department and EMS Department. And lastly Chief Kandrac thanked Councilwomen Covi for raising the monies to purchase a Hotstick, equipment that is used to check live wires.

#### Mayor’s Report – Mayor Kobistek

Mayor Kobistek reported that there were 28 criminal arrests, 57 traffic citations, 114 parking tickets issued, and 844 self-initiating activity and total complaints.

Dax, police dog, is back to full duty and he is doing well.

There have been a few incidents of vehicles that are being ransacked, the Mayor asked all residents to keep their vehicles locked and all valuables out of sight. Also be aware of scams and be very careful not to respond to these scams. You can report any possible scams to the Attorney Generals Office. If you notice a vehicle that has expired registration please call 911 to report these vehicles.

The Bottom Dollar Supermarket is now underway and should be completed sometime in November.

The Salvation Army’s Outreach facility on Main Street will be open in June and the facility on Washington Avenue will close.

Mayor Kobistek reported the results of the 2010 Census data. Mayor Kobistek thanked Chief Harbin and all those involved in the 5K Race. He also thanked Steve Beuter and the wonderful volunteers for the great job with the Carnegie Clean-Up Day.
