MOTION to by Councilwoman Demko to approve Pay Application Request No. 6 from Mongiovi & Son Excavating in the amount of \$8,284.94 for repair work completed between August 1, 2010 and September 30, 2010 for the 2009 Sanitary Sewer Point Repair as required by the Consent Order. PUBLIC SAFETY

MOTION by Councilman Sarsfield to approve a Memorandum of Understanding between the Carlynton School District and the Carnegie Police Department relating to procedural guidelines in place regarding acts of violence on school property, school sponsored activities and school buses. Second by Councilman Veres. MOTION CARRIED

MOTION to by Councilman Sarsfield to permit the Carnegie Volunteer Fire and Rescue Bureau to utilize eight (8) parking spaces in Borough Lot #7 for their annual Christmas Tree sale beginning November 24th, 2010. Second by Councilwoman Covi. MOTION CARRIED

COMMUNITY DEVELOPMENT:

MOTION by Councilman D'Loss to repeal all Agreements and/or Ordinances that created a Parking Authority in Carnegie Borough. Second by Councilman Veres. MOTION CARRIED

MOTION by Councilman D'Loss to advertise Ordinance No. 2342 an Ordinance to re-establish a Parking Authority in Carnegie Borough. Second by Councilwoman Covi. MOTION CARRIED

MOTION by Councilman D'Loss to vacate a portion of Williams Way, between Chestnut Street and Hays Street, contingent on CVS purchasing the properties on both sides of Williams Way as part of their proposed development. Second by Councilwoman Demko. MOTION CARRIED

MOTION by Councilman D'Loss to approve a Temporary Tax Exemption Application of Karma Investments for the properties located at 201-205 Mary Street, Block and Lot Numbers 103-L-26 and 103-L-27, and jointly forward said application with Carlynton School District to the Allegheny County Board of Property Assessment Appeals and Review in accordance with Ordinance Number 2059 of February 12, 1996.

MOTION by Councilman D'Loss to ratify the decision by the Planning Commission to approve a lot consolidation of certain portions of property located at 408 Franklin Avenue (Front), 408 Franklin Avenue (Rear) and 815 Charles Street.

REPORTS

Borough Manager

Mayor Kobistek

Mayor Kobistek reported that there were 29 criminal arrests, 101 traffic citations, 186 parking tickets issued, and 988 self-initiating activity and total complaints were handled by the Carnegie Police Department for the month of October. Mayor Kobistek reported five disruptive crime reports and when comparing October 2009 to October 2010 there was a decrease in the number of disorderly conducts reported in Carnegie Towers.

The Mayor addressed the issue of abandoned vehicles, vehicles with expired license plates, and asked residents to report the abandoned vehicle to the police department.

The Salvation Army, Chartiers Service Center located on Washington Avenue will be closing. The Salvation Army will hold a Public Meeting on November 15th to discuss the reorganization and answer any questions or concerns residents may have.

Mayor Kobistek updated the residents on the Carlynton School Board activity regarding the Elementary Schools. There are (10) plans that are being reviewed and the Mayor recommends the residents of Carnegie attend the meetings and check out the information on the Carlynton School District web-site @ www.carlynton.k12.pa.us.

The Mayor thanked Carol Covi for a wonderful job with the Halloween Promenade, the children and family members enjoyed the event. The Mayor also thanked Chief Jeffrey Harbin for coordinating the "Toys for Tots 2010" campaign. This toy drive has been very successful in the past.

GENERAL PUBLIC COMMENT

Robert, 651 Cabbage Street, expressed concern with the number of abandoned houses in Carnegie and problems associated with those properties. He also requested information regarding the demolition of a property.

Councilman Catena and Councilman Sarsfield explained the demo process and addressed the process used for reporting and controlling rodents.

COUNCIL GOOD and WELFARE

Councilman Catena, Councilwoman Covi, Councilwoman Demko, Councilman D'Loss, Councilman Sarsfield, and Councilman Veres wished all Veterans a Happy Veterans Day and thanked all those who are serving and those who have served. Councilwoman Covi also thanked all of the people for their generous donations for the Halloween Promenade.
