MOTION to approve a proposal from the Allegheny County Housing Authority as recommended by the Planning Commission to reconfigure the apartment complex located at 514 Lydia Street and acquire the piece of land located on parcel number 66-E-258 to utilize as parking. The reason for acquiring these extra parking spaces is because the apartment reconfigurations will increase the number of rental units in the complex. Second by Councilperson Sarsfield. UNANIMOUS. MOTION to approve a Bond reduction for Phase 2 of the Prestley Heights Development in the amount of \$51,672.80 which will reduce the Bond from \$104,495.51 to \$52,822.71 as recommended by Gateway Engineers in their letter dated September 29<sup>th</sup>, 2011. ### **Mayor’s Report**

Mayor Kobistek reported that there were 41 criminal arrests, 42 traffic citations, 194 parking tickets were issued and 827 self-initiating activity and total complaints. The Mayor reported on a couple important items from the crime logs- On September 12<sup>th</sup>-Carnegie Police department along with the surrounding police departments were alerted to a series of car break-ins on Woodridge Drive. Carnegie Police and the other police departments apprehended several suspects. Please remember to lock your car and remove or conceal all personal items There were (2) home burglaries on Library Avenue – in both instances the homes were unlocked. Please keep your homes locked. The Mayor thanked Chief Harbin for increasing traffic targets for the new school year. Last month (10) abandoned vehicles were addressed. This year’s first career lunch at Carnegie Elementary School was a big success thanks to Officer Quattro, Officer DAX, and Chief Harbin. They spoke about careers in Law Enforcement and the importance of receiving an education.

Campbell’s Run Creek Update: The area below the bridge – at this point the Chartiers Valley Flood Authority solicitor is finishing up his work with the Army Corps of Engineers. The design portion is completed and the funding is still in place. The projected start date is December 2011. Sunday, November 20<sup>th</sup> the Carnegie Boys and Girls Club will host a fund raiser at the South Fayette Alpine Club – call the Boys and Girls Club for additional information. The Bottom Dollar Super Market is scheduled to open by the end of October. Cantley’s Night Life will host its 2<sup>nd</sup> Annual Fishing Tournament on October 15<sup>th</sup> – this fund raiser supports the Carlynton Jr/Sr Band.
