FOREWORD

History

This comprises the codification of the ordinances of the Borough of Carnegie. Incorporated on March 1, 1894, Carnegie was formed when two smaller boroughs, Mansfield and Chartiers facing each other across Chartiers Creek and joined by family, geography, industry and religions, merged. The new borough was named after Andrew Carnegie himself in return for his gift of both Carnegie High School which he had built, and the Andrew Carnegie Free Library and Music Hall which he had built and endowed, and which keeps watch over the community from its perch atop Library Hill today.

The Code of Ordinances of the Borough of Carnegie was prepared by Keystate Publishers, Inc., and adopted by the Borough of Carnegie Borough Council on December 10, 2012, by *Ord.* 2384.

Organization

The Code contains four parts which are (1) the valid current ordinances of the Borough of Carnegie contained in Chapters 1 through 27, (2) the Appendix, which lists by abstracted title all ordinances of a temporary or "one time" nature, (3) the Table of disposition of each ordinance ever enacted by the Borough of Carnegie, and (4) the Index, which is an alphabetical arrangement of subjects.

In the Code each Chapter is separated by a divider tab, and specific ordinances can be located by subject on the contents page at the beginning of each Chapter. The Index may also be used to search for a subject when one is looking for general information on a particular subject, or if it is not known in which Chapter the subject might be found. The Appendix consists of several general categories containing a chronological listing of short subject descriptions along with a reference to the original ordinance and its date of enactment, if known.

The Table of disposition indicates what action has been taken by the Borough of Carnegie Borough Council with regard to every ordinance ever enacted. An ordinance has either been (1) specifically repealed, (2) superseded by another ordinance, (3) is located in a Chapter of the Code book, or (4) is located in the Appendix. Annual tax rate and budget ordinances are located only in the Table of Disposition. The Table of Disposition is a cross reference to the original ordinance books of the Borough of Carnegie, and to the location within the Code of each ordinance by number.



ORDINANCE NO. 2384

AN ORDINANCE ADOPTING THE CODE OF ORDINANCES OF THE BOROUGH OF CARNEGIE, ALLEGHENY COUNTY, PENNSYLVANIA; CONSOLIDATING, REVISING, AMENDING AND REPEALING CERTAIN ORDINANCES; ENACTING CERTAIN NEW PROVISIONS; PROVIDING A PROCEDURE FOR AMENDING THE CODE AND FOR THE CITATION OF THE CODE AND THE EFFECTIVE DATE THEREOF; ESTABLISHING RESPONSIBILITY FOR MAINTENANCE OF THE CODE; SAVING CERTAIN PROVISIONS FROM REPEAL; AND PRESCRIBING PENALTIES FOR VIOLATION.

The Borough of Carnegie hereby ordains:

Section 1. Adoption. The *Borough of Carnegie Code of Ordinances*, as prepared and published for the said Borough of Carnegie by Keystate Publishers, Inc., is hereby adopted as a consolidation, codification and revision of the ordinances of the Borough of Carnegie. Section 2. Citation and Effective Date. The codification referred to in Section 1 of this ordinance shall be known and cited officially as the *Borough of Carnegie Code of Ordinances*, and all future ordinances shall make reference thereto. This ordinance shall become effective immediately upon publication of notice of final enactment as required by law.

Section 3. Saving Clause. The provisions of the *Borough of Carnegie Code of Ordinances*, so far as they are the same as those ordinances and regulations in force immediately prior to the adoption of said Code, are intended as a continuation of such ordinances and regulations and not as a new enactment. The provisions of the *Borough of Carnegie Code of Ordinances* shall not affect any suit or prosecution pending or to be instituted to enforce any of the prior ordinances or regulations.

Section 8. Procedural Changes. The following minor procedural changes have been made to existing Borough of Carnegie ordinances:

Section 9. Amending the Code of Ordinances. The procedure for amending the Code of Ordinances shall include the citation of the Chapter, Part, Section and subsection to be amended, revised, repealed or added as follows:

A.	<u>Amendment or Revision</u> - "Chapter, Part, Section, Subsection is hereby amended [revised] to read as follows"
В.	Additions - "Chapter, Part, Section, Subsection is hereby amended by the addition of the following"
C.	Repeal - "Chapter, Part, Section, Subsection is hereby repealed in its entirety."

Section 10. Responsibility for Code of Ordinances. It shall be the responsibility of the Borough of Carnegie Secretary to maintain an up-to-date certified copy of the Code of Ordinances. This copy shall be the official copy of the *Borough of Carnegie Code of Ordinances* and shall be available for public inspection.

Section 11. Penalties. It shall be unlawful for anyone to change, alter or tamper with the Code of Ordinances in any manner which will intentionally misrepresent the laws of the Borough of Carnegie. Whosoever shall violate this Section shall be guilty of an offense under §4911, "Tampering with Public Records or Information," of the Crimes Code, 18 Pa.C.S.A. §4911, and shall be prosecuted under that Section of the law.

Section 12. Severability of Parts of Codification. It is hereby declared to be the intention of the Borough of Carnegie that the Chapters, Parts, Sections, paragraphs, sentences, clauses and phrases of this codification are severable. If any Section, paragraph, sentence, clause or phrase of this Code is declared unconstitutional, illegal or otherwise invalid by the judgment or decree of a court of competent jurisdiction, that invalidity shall not affect any of the remaining Chapters, Parts, Sections, paragraphs, sentences, clauses or phrases of this codification.
