BOROUGH OF CARNEGIE ALLEGHENY COUNTY, PENNSYLVANIA ORDINANCE NO. 2463

AN ORDINANCE OF THE BOROUGH OF CARNEGIE, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, AUTHORIZING THE DELEGATION OF POWERS SET FORTH IN A JOINT MUNICIPAL AGREEMENT FOR LAW ENFORCEMENT SERVICES WITH RESPECT TO THE USE OF HOLDING CELLS BY THE PARTIES HERETO.

WHEREAS, the Borough of Carnegie and the communities set forth herein, namely the Borough of Heidelberg, having determined that the joint and cooperative provision of certain police services is in the mutual interest of the said municipalities, and will preserve the health, safety and welfare of all the communities subject to said police agreements; and

WHEREAS, the Borough of Carnegie and the various communities set forth herein have entered into a Joint Municipal Agreement For Law Enforcement Services, setting forth the terms and conditions of the joint police services; and

WHEREAS, cooperation between the Borough of Carnegie and the various communities in the exercise and performance of their governmental powers, duties and functions is authorized by the various Acts of the General Assembly, including but not limited to the Borough Code, and the Intergovernmental Cooperation Act.

NOW, THEREFORE, be it Ordained and Enacted by the Borough Council of the Borough of Carnegie, Allegheny County, Commonwealth of Pennsylvania, and it is hereby Ordained and Enacted by the authority of the same as follows:

1. Pursuant to the Intergovernmental Cooperation Act, 53 Pa. C.S.A. Section 2301, et seq., the terms and conditions of the Joint Municipal Agreement for Law Enforcement Services by and between the Borough of Carnegie and the following community, Borough of Heidelberg, are hereby approved and adopted. Further, the

Borough is authorized to enter into any extension of said Agreements beyond the current terms set forth in said executed Agreements.

- 2. Pursuant to the Intergovernmental Cooperation Act, 53 Pa. C.S.A. Section 2307, the following are specified:
 - a. The conditions of the Agreement are set forth in Exhibit A.
 - b. The duration of the term of the Agreement is set forth in Exhibit A.
 - c. The purpose and objectives of the Agreement, including the powers and scope of authority delegated in the Agreement are set forth in Exhibit A.
 - d. The manner and extent of any financing the Agreement are set forth in Exhibit A.
 - e. The organizational structure necessary to implement the Agreement are set forth in Exhibit A.
 - f. The manner in which personal property is to be acquired, managed, licensed or disposed of is set forth in Exhibit A.
 - g. No new entity is created under 53 Pa. C.S.A. Section 2307(7) which will have employees.
- 3. The appropriate authorized officers of the Borough of Carnegie are hereby authorized to execute and enter into said Joint Municipal Agreement for Law Enforcement Services on behalf of the Borough of Carnegie.
- 4. If any sentence, clause, phrase or section of the Ordinance is for any reason found to be unconstitutional, illegal or invalid, such uncontistionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, phrases, sections or parts of this Ordinance. It is hereby declared as the intention of the Borough Council of the Borough of Carnegie that this Ordinance would have been adopted had such unconditional, illegal or invalid sentence, clause, phrase, section or part thereof not been included therein.
- 5. Any other Ordinance or parts thereof Inconsistent with this Ordinance shall be and are hereby expressed repealed.
- 6. This Ordinance shall be effected as provided by law.
