Public Works. Councilman Boyd reported in the absence of Councilman D'Loss. He reported that PAWC with repave Justus Avenue. Also, Council has approved the storm water project for Plum Street. With regard to Carnegie Park, our contractor will apply an acrylic surface to the street hockey and tennis courts in late April or early May. New items to the park will include a new basketball court and a golf disc course. A new storm water pipe will be installed on Broadway Street. ALCOSAN will pay 85% of the cost and the Borough will pay the remaining cost.

<u>Manager's Report</u>. The Borough Manager reported that R&B construction will commence work on Plum this upcoming Monday for three to four weeks. All residents will be notified.

<u>Carnegie Volunteer Fire Dept. & EMS Report</u>. For the month of March fire calls were 10, EMS calls were 61.

<u>Mayor's Report.</u> For the month of March 2017 -- Criminal Arrests and Citations: 27; Traffic Citations: 77; Parking Tickets: 247; Complaints and Self-Initiating Activities: 915.

The Borough in conjunction with State Representative Anita Kulick, and County Councilman Pat Catena will be holding a shredding event on Saturday, April 22, 2017 from 9:00 a.m. to 12:00 noon in the municipal parking lot.

The Mayor reminded everyone about the Carnegie Volunteer Fire Department's 10th Annual 5K Run/Walk on Saturday, April 29, 2017 commencing at 8:00 a.m. Registration is \$20.00.

The Boys & Girls Clubs is accepting summer camp registrations. Summer camp this year will run for 10-weeks.

On Sunday, April 23, 2017, the Borough and the Indian Community Center will hold its 2nd Annual of Colors at the East Main Street Parking Lot from 12:00 to 4:00 p.m. There will also be a band, and the first 200 people will receive a free t-shirt.

The Campbell's Run Road re-opening is tentatively scheduled for mid-May.
