<u>Mayor's Report</u>. For the month of August 2017 -- Criminal Arrests and Citations: 23; Traffic Citations: 69; Parking Tickets: 386; Complaints and Self-Initiating Activities: 800.

The Mayor reported on the heroin issue for 1/3 of this year in our community, reporting one death and 16 overdoses in which the individuals have been revived by Narcan via our Police Department.

The Mayor reported on the current scams associated with the hurricanes via unsolicited emails soliciting money for the hurricane victims.

The Mayor shared an update on the 112-year old bat that was signed by baseball player Honus Wagner. The collector of this pro-type bat displayed the bat at the Honus-Wagner Museum at the Carnegie Historical Society on September 1 and 2, 2017. He thanked those all involved in displaying the bat.

The Borough is working on a mural which will be on the side of the Salvation Army building. The Mayor thanked Bob Podurgiel and Phil Salvato for their work in soliciting money for this mural.

He also commented on the Carnegie Celebrates Jazz wherein Phil Salvato was honored with the Proclamation as a leader of arts in this community.

The second Open Streets Carnegie will be held on Saturday, September 23, 2017 from 9:00 a.m. to 1:00 p.m.

He reported on the success of the Carnegie Boys & Girls Clubs for 2017.

The Mayor reported on the parking issues of Lydia Street. Lydia Street is a two-hour parking area and will be strictly enforced.

The Mayor gave recognition to Patriot's Day and 9/11. He also reported on the many events held today in Carnegie in honor of this day.

Chartiers Area Flood Control Authority has completed the work on the culverts in the Thornburg and Crafton areas and also the street banks in Carnegie. We now qualify for federal disaster funds and are in compliance.

Our Department of Public Works will be shoring up the stream bank of Campbell's Run Creek.

The Knights of Columbus will be hosting their annual food drive on September 23 and 24, 2017. The drive benefits the St. Vincent DePaul Food Bank.
