President's Report – nothing for this evening.

MANAGER'S REPORT – We have received a grant from the PA Dept. of Community and Economic Development in the amount of \$85,000 for flood mitigation. This will go towards work in Campbells Run along Lexington Court to remove any debris along the creek to help the flow coming from upstream. We've also received a \$30,000 grant from Active Allegheny which will be for a "Rails to Trails" connector study to possibly connect with the Panhandle Trail in Collier Township. The Farmers Market ended a few weeks ago. We had 34 vendors participate and many have already confirmed for next year.

CARNEGIE VOLUNTEER FIRE DEPT & EMS REPORT – for the month of September 2019 there were 17 fire calls and 105 ambulance calls.

MAYOR'S REPORT – Police Dept. activity for September 2019; Criminal Arrests and Citations – 14; Traffic Citations – 11; Traffic Stops –23; Parking Tickets – 73; Complaints and Self-Initiated Activity –806.

I attended an event at the Library called "Carnegie Swings". It was an enjoyable event. Congratulations to Maggie and staff for putting this on. Heard a lot of positive feedback for Carnegie's first Fall Festival. Hopefully this will become one of Carnegie's annual events. On the calendar for the rest of October: Wednesday, October 16th, 7-8 p.m. at SEAS will be the Substance Addiction Ministry Open House – 330 Third Avenue; Thursday, October 17th at 6 p.m. is the Carnegie Elementary School Open House; Saturday, October 19th from 10 a.m. to 4 p.m. is the Carnegie Church Tour. This is an opportunity to visit Carnegie's beautiful houses of worship; Saturday, October 26th at noon is the annual children's Halloween promenade. Registration is at noon on the Main Street Bridge and the promenade starts at 12:30. Kids will receive free treat bags and there will be prizes awarded for the top three costumes in five different age groups. Following the promenade, local business will be passing out candy as well as local churches which will be participating in a Trunk or Treat. On Thursday, October 31st, children in Carnegie will celebrate by trick or treating from 6 p.m. to 8 p.m.

Friday, November 1st is the Boys and Girls Club Annual Comedy Night Fundraiser. This will be held at Cefalo's Banquet Hall on Washington Avenue. Proceeds are used to provide summer camp scholarships for many children in the community. This fundraiser also supports the teen employment program. Tickets are \$75. For more information, please contact Dom at the Boys and Girls Club. Wednesday, November 6th from 11 a.m. to 2 p.m. there will be a free career fair at the Library sponsored by the JFCS and the United Way.

Save the date for Saturday, December 7th as Carnegie Celebrates the Season. Santa will be at the Library from 11 a.m. to 1 p.m. Crafts and fun activities will begin at 10 a.m. The night before, Friday, December 6th, we will be having the lighting of the tree, moved this year to the Municipal Building.

GENERAL PUBLIC COMMENT

Bob Podurgiel – Shade Tree Commission – would like status of the placement of the tree by PNC Bank. We have found a 14' Norway spruce tree, at a cost of \$450, to be planted. We will need the help of DPW to plant it.

Philip Angus (516 Morrow) – wanted to discuss the paving of Harrison Avenue. It's only been paved one time in 40 years. Was assured by Keith Hatcher that it is on the list to be paved in the spring.

Jeannie Williams – Carnegie resident and employee of JFCS Career Counseling – talked about job fair on Wednesday, November 6th at the Library. We will have some large employers there from different sectors and industries. There will be a preparation session for the job fair. This will be located at the borough building on November 4th from 10 a.m. to noon.

Emmett Freshwater – On September 24th & 25th at Cefalo's Banquet Hall, there was a gathering of disabled and homeless veterans. The veterans received a delicious meal and clothing to help with the upcoming winter weather. Introduced Mr. Len Cefalo and Mr. Al Montuoro, from the Carnegie Elks Club.

Mr. Al Montuoro - On September 24th & 25th, the Carnegie Elks Lodge 831, along with Allegheny Lodge, hosted a dinner to feed homeless veterans that are in transition. This is the second dinner we've done this year and Len Cefalo really stepped up. Over the two nights, we served 80 veterans. The monies from the Spotlight Grant and the Freedom Grant, both from the Elks National Foundation, and monies donated from Carnegie Lodge members, Allegheny Lodge members, American Legion Post 82 and clothes donated by the CWA 13000, as well as money donated from one church and one business in Carnegie made this possible. The winter clothes were distributed to the homeless, at-risk veterans. Each veteran was treated to a delicious meal and was able to select brand new clothing. We sat with the veterans and listened to their stories. We had help from different organizations. We purchased \$750 worth of Target gift cards which will be used to purchase items for the veterans' needs. We're going to do it again next year at Cefalo's. We need help getting in touch with the veterans agencies.

Len Cefalo – discussed how much the Carnegie Elks helps the homeless veterans. Thank you to the Carnegie Elks and Allegheny Elks, they are tremendous organizations. If there is any way that Council can help us put the word out for next year's even that would be a tremendous help. Discussed how much the Borough of Carnegie and its residents want to help.

Maggie Forbes – Carnegie Library – discussed how much the Benevolent and Protective Order of Elks helps not only veterans, but the community. A great and caring organization. We reached out to Carlynton School District. We had twelve high school students that used their day off to help set up and organize this event. Carnegie is really a wonderfully, helpful community.

Councilperson Canofari – on this day in 1964 Rev. Martin Luther King, Jr. was awarded the Nobel Peace Prize for leading non-violent resistance to end racial prejudice in the United States.
